I, [REDACTED], certify that I am the copyright holder of at least one hundred works that have been scrapped over two accounts and posted to a dataset hosted on your site. Many of these artworks are original creations featuring original characters. Such as 'Meet the Artist!!!' which is a self portrait, 'The Kiss' which is of a ginger woman and her husband in the pose of Gustav Klimt, and 'Darling of the Fire' which is of the the same ginger woman, wearing a blue dress and wearing a blue dress. As well as pieces from my old account, like 'Emoest Bean' which is a girl with black hair, in a 2015 emo's outfit, 'Classic' which is of a red headed woman lounging in a chair, and 'Haru' which is of a cat boy in a skirt. There are far too many of my works taken against my copyright to list in a reasonable sized email.

The material hosted on nyuuzyou/paintberri hosts plenty of copyrighted artworks by myself and other creators on the platform Paintberri. These posts are located at <https://huggingface.co/datasets/nyuuzyou/paintberri/viewer/metadata/train?q=WowABaby> and <https://huggingface.co/datasets/nyuuzyou/paintberri/viewer/metadata/train?q=Vena> as part of a databank of work stolen to use for generative AI.

In good faith, I believe the works in this dataset are not authorized to use by the copyright owner, agent of the copyright owner, or the law. Under penalty of perjury, I confirm the above information is accurate and that I am authorized to act on behalf of the copyright holder that is being infringed on.

I request that you expeditiously remove all materials taken from the two accounts, Vena and WowABaby.
