403 001.Step 2: Take a print of the proforma of the application form, or request a hard copy from the concerned authority.Step 3: In the
application form, fill in all the mandatory fields, paste the passport-sized photograph (signed across), and attach copies of all the
mandatory documents (self-attest if required).Step 4: Submit the duly filled and signed application form along with the documents to the

Landowner" in the context of new construction and re-construction?The ownership documents or NOC from the landowner are essential
to establish legal ownership or permission for the construction on the particular property. This ensures that construction activities are
conducted with the necessary rights and permissions in place.How does the scheme determine the amount of financial assistance for
construction and repairs?The financial assistance for construction, re-construction, and repairs is fixed at â¹ 3,00,000 and â¹ 1,50,000,
respectively. These amounts are established to cover the costs associated with house-related activities and ensure equitable distribution
of assistance.Can an applicant avail both the construction and repair benefits under this scheme?Yes, an applicant can avail either the
benefit for construction/re-construction or the one for repairs. However, they cannot avail both benefits simultaneously for the same
property.Could you provide insights into the additional documents required for new construction or re-construction under the scheme?
Certainly. For new construction or re-construction, ownership documents or a No Objection Certificate (NOC) from the landowner and a
construction license issued by the competent authority are required. These documents ensure legal compliance and transparency in the
construction process.What are the specific benefits offered under this scheme?The scheme offers two categories of financial assistance:
â¹ 3,00,000 for the construction of a new house or re-construction of an existing one, and â¹ 1,50,000 for repairs to an existing
house.Who is eligible to apply for the benefits of the "Atal Asra Yojana"?Any individual who is part of the Scheduled Tribes
community residing in Goa can apply for the scheme. Eligibility is also determined by the annual income of the applicant's family,
which should not exceed â¹ 3,00,000.Could you explain the main purpose of the "Atal Asra Yojana" initiated by the Department of
Tribal Welfare, Government of Goa?The "Atal Asra Yojana" has been established to provide financial support to individuals belonging
to Scheduled Tribes communities within the state of Goa. The scheme aims to assist them in house-related matters such as construction,
re-construction, and repairs, thus improving their living conditions.Which department manages this scheme?This scheme is managed by
