- l. In response to a brief letter from the undersigned, which queried his general plans, subject has replied per attachment. Please note that he can make himself available after 4 November 1968 for discussions with Melbourne. The Station defers to Bangkok and Director whether it is still desired that we summon subject to Melbourne for talks along the lines indicated in reference D.
- 2. For Rangoon: Note penultimate paragraph of subject's letter in which he indicates that his daughter and family are planning to leave Rangoon permanently. The manner in which this is phrased leaves it unclear whether they are attempting this overtly or working behind the scenes. The Station notes from RANGKOK 9542 of 1 May 1968 that the daughter is married to a Burma Air Force pilot. Since we do not have any names, it may be unlikely that Rangoon would have any information on the case.
